CIRCULAR

Sub : TD – Displaying of Tax Schedule, Registration charges, etc., for registration of motor vehicles and filling nominee details in Form-20 – Instructions to dealers – For strict adherence – Reg.

It is informed that complaints have been received from the vehicle owners stating that the Motor Vehicle Dealers are levying additional charges apart from the applicable fees and Road tax prescribed for the registration of a motor vehicle.

2. Therefore, all the Motor Vehicle Dealers are hereby directed to ensure the display of the current Tax Schedule, Registration Fees, Service Charges, etc., prescribed for the vehicles being sold by the respective Dealers. The display board containing the particulars mentioned in the Annexure should be made noticeable to the customers/vehicle owners.

3. Further, it is directed that apart from applicable charges to be levied, no other additional charges should be collected from the owner of the vehicle and appropriate receipt should be issued towards the payment.

4. It is also informed that the Ministry of Road Transport and Highways has notified the Central Motor Vehicles (Seventh Amendment) Rules, 2021 vide Notification F.No. RT-11036/126/2020-MVL dated 08.04.2021 [G.S.R. 277(E)] of the Ministry of Road Transport and Highways, New Delhi. The amended rules were made for the feasibility of transfer of ownership of a vehicle on the death of an owner. As such, the Dealers are directed to obtain the Nominee details alongwith identity proof from the vehicle owner and same shall be duly filled-in while generating Form-20 in Vahan-4 portal in respect of the vehicles being registered.

5. Hence, all the Motor Vehicle Dealers of the U.T. of Puducherry are hereby directed to comply with the above instructions without any deviation and shall ensure the display of the said (i) Fees and Tax structures and (ii) significance of choosing nominee during registering a vehicle. The display shall be made visible to the owner of the vehicles/probable customers at the prominent places invariably in the showroom.


