
In partial modification to the revised Policy Guidelines/ Procedural Guidelines for Licensing / Registration /Fitness for E-rickshaw/Syllabus for imparting instructions in driving E-rickshaw notified vide G.O.Ms.No.22/Tr. Sectt./2017, Puducherry, dated 15th March, 2017 and published in Issue No.10, Part-II of the Extraordinary Gazette, dated 21st March, 2017, the amendment is made as follows, namely:-

AMENDMENT

In the Revised Policy Guidelines/Procedural Guidelines for Licensing/Registration/Fitness for E-rickshaw/Syllabus for imparting instructions in driving E-rickshaw,-

- (i) in para 5, the existing sub-para (C) – Authorization to drive transport vehicles (Badges), shall be omitted.
- (ii) in para 5, under the existing sub-para (D), in item (I), the existing sub-items (ix), (x) and (xi), shall be omitted.
