2. Notification No.A-34012/13/2023/DP&AR (Exam), dt.25.10.2023 of the Department of Personal and Administrative Reforms (PW), Puducherry.

Pursuant to the Notification second cited, the provisionally selected candidates for the post of **Enforcement Assistant** (Group 'C' Non-Gazetted, Technical) in the Transport Department, Puducherry are hereby instructed to appear for certificate verification, as per the schedule (12.03.2024) indicated against their names in the Annexure I, with the following original Certificates along with one set of self-attested Photostat copies of the same:-

- (1) Certificate in proof of age (Birth Certificate / Board Certificate);
 - (2) Certificate in proof of Educational Qualification;
 - (3) 'Nativity / Residence Certificate' issued by an Officer of the Department of Revenue and Disaster Management, Puducherry not below the rank of Deputy Tahsildar. The certificate should have been issued within one year from the date of notification of results of this recruitment test;
 - (4) 'Community Certificate' obtained in the prescribed form issued by an Officer of the Department of Revenue and Disaster Management, Puducherry not below the rank of Deputy Tahsildar. The certificate should have been issued within one year from the date of notification of results of this recruitment test;
 - (5) Original Light Motor Vehicle Driving Licence (Form 7 (Rule 16(2))).
 - (6) Original 'Discharge Certificate' and the 'Registration' particulars with the Department of Sainik Welfare, Puducherry in respect of 'Ex-Servicemen' candidates;
 - (7) 'Disability Certificate' issued by the Medical Authority, Government of Puducherry in case of 'Persons with Benchmark Disabilities' (PwBDs) candidates; and
 - (8) The candidates selected under 'EWS' category should submit 'Income and Asset Certificate' in the prescribed form issued by an Officer of the Department of Revenue and Disaster Management, Puducherry not below the rank of Deputy Tahsildar. The certificate should have been issued within one year from the date of notification of results of this recruitment test;
 - (9) Original Valid Employment Exchange Registration Certificate.
2. No Travelling Allowance will be paid for the Certificate Verification.
3. In-service candidates should obtain the 'Service Certificate' from the Head of Department / Office indicating their name, designation, educational qualification, date of initial appointment with name of Post / category to which he/she belongs to etc, in support of their claim.
4. Mere certificate verification will not confer any right on any candidate to claim appointment as a matter of right.
5. **If the candidate fails to appear for certificate verification on the date and time prescribed, the provisional selection will be treated as CANCELLED.**

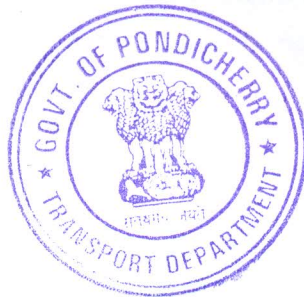
