ORDER:-

The following notification shall be published in the Extraordinary Official Gazette of the Government of Puducherry:-

NOTIFICATION

In supersession of G.O's 7th and 8th readabove, save as respect things done or omitted to be done before such supersession, the Lieutenant-Governor, Puducherry is hereby pleased to issue the following guidelines for reservation of fancy registration number through e-auction for the motor vehicles, namely:-

- 1. The allotment of fancy registration numbers shall be done through e-auction on the web based online fancy number module of Vahan 4.0 or any other updated software approved by the Government, from time to time, for registration of motor vehicles.
- 2. The process of e-auction for the succeeding series shall commence only when the registration numbers in the current series crosses 8000.
- 3. The fancy registration numbers are categorized into five groups as detailed in the table mentioned below:-

- 4. Any applicant, who is residing or having place of business, where the vehicle is usually kept, irrespective of the jurisdiction of the authority in the Union territory of Puducherry, intending to participate in the e-auction has to pay a sum of Rs.250/- as registration fee, which is non-refundable in nature alongwith the respective 'Fixed Contribution' based the category and type of vehicle opting for purchase. In case of competition for same number, the higher class of vehicle prevails.
- 5. Each bid shall be in multiples of Rs.1,000/- above the 'Fixed Contribution'.
- 6. After the completion of bidding, the successful highest bidder(H1) is bound to pay the balance bid amount, which is to be paid by deducting the 'Fixed Contribution'.
- 7. The 'Fixed Contribution' paid by the unsuccessful bidder shall be refunded.
- 8. The successful highest bidder (H1) should pay the balance bid amount, if any, after completion of the process of e-auction within the stipulated time of three days, succeeding the date of completion of auction. Failing which, the registration number for which he has submitted the bid shall not be allotted to him and the 'Fixed Contribution' paid by him shall not be refunded. Thereafter, the said reserved number shall be allotted to the second highest bidder (H2). In case, if the second highest bidder (H2) also fails to pay the bid amount within the next three days, on the seventh day, the said number will be opened for reservation on 'first come first served' basis.
- 9. If for any reason, the vehicle for which a particular number has been reserved is not produced by the person who reserved the number for registration within a period 90 days from the date of reservation of the number, such reservation shall cease to have effect and the person in whose favour the number is reserved shall deemed to forgo his right.
- 10. The unreserved numbers except the numbers mentioned under categories 1 to 3, shall be made available for allotment under 'first come first served' basis against the payment of 'Fixed Contribution' mentioned in the table under the corresponding category, after completion of entire e-auction process.
- 11. The numbers other than reserved in the running series except the numbers mentioned under category 1 to 3 shall be assigned randomly with a consecutive pocket of 100 Nos. each, excluding the numbers whose sum of all digits equals to '8'. i.e. the unreserved numbers mentioned in the category 4 shall be included for allotment by the system.

- 12. The unreserved numbers whose sum of all digits in a number equals 8 shall be allotted under 'first come first served' basis on payment of corresponding 'Fixed Contribution' mentioned in the table.
- 13. The registration numbers reserved by any applicant for any particular type of vehicle shall be transferable to another type of vehicle of higher 'Fixed Contribution', provided, if the said applicant agrees to pay the difference in 'Fixed Contribution'. In case of vice-versa, the difference of excessively paid 'Fixed Contribution' shall not be refunded. Moreso, the reserved registration number is not transferable in the name of any other person.
- 14. The Transport Commissioner shall exercise every right to reserve any registration number as may be considered necessary to be assigned to the vehicles of Government without payment of 'Fixed Contribution'.
- 15. The bid amount paid by the successful bidder shall be credited invariably into the Chief Minister's Welfare Fund.
