**NOTIFICATION**

In exercise of the powers conferred by the proviso to article 309 of the Constitution of India read with the Notification No.F.5/4/65-GP, dated 11<sup>th</sup> January 1965 of the Ministry of Home Affairs, Government of India, New Delhi, and in supersession of the notification issued in G.O.Ms.No.42/84, dated 15<sup>th</sup> September, 1984 of the Personnel and Administrative Reforms Wing (Transport), Chief Secretariat, Government of Puducherry, and published in the supplement to the Official Gazette No.48, of the 27<sup>th</sup> November 1984, save as respects things done or omitted to be done before such supersessions, the Lieutenant-Governor, Puducherry hereby makes the following rules regulating the method of recruitment to post of Motor Vehicle Inspector, Group 'B' Non-Gazetted, Non-Ministerial in the Transport Department, Government of Puducherry, namely:-

**1. Short title and commencement.-**

(1) These rules may be called the Government of Puducherry, Transport Department, Group 'B' Non-Gazetted, Non-Ministerial post of Motor Vehicles Inspector Recruitment (Amendment) Rules, 2025.

(2) They shall come into force on and from the date of their publication in the Official Gazette.

**2. Application.-** These rules shall apply to the posts specified in column(1) of the Schedule annexed hereto.

**3. Number of posts, classification and Level in the Pay Matrix.-** The number of the said posts, their classification and the Level in the Pay Matrix attached thereto, shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.

**4. Method of recruitment, age limit and other qualifications.-** The method of recruitment to the said post, age limit, qualification and other matters relating thereto, shall be as specified in columns (5) to (13) of the said Schedule.

**5. Disqualification.-** No person,-

(a) who has entered into or contracted a marriage with a person, having a spouse living; or

(b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Lieutenant-Governor may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

**6. Power to relax.-** Where the Lieutenant-Governor is of the opinion that it is necessary or expedient so to do, he/she may, by order and for reasons to be recorded in writing and in consultation with Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.

**7. Saving.-** Nothing in these rules shall affect the reservations, relaxation in upper age limit and other concessions required to be provided for the scheduled castes, scheduled tribes, Ex-Servicemen and other special categories of persons in accordance with the orders issued by the Government from time to time in this regard.



**DRAFT SCHEDULE**  
**RECRUITMENT RULES FOR THE POST OF MOTOR VEHICLES INSPECTOR**

1. Name of Post : **MOTOR VEHICLES INSPECTOR**
2. Number of Posts : 12 (Twelve) (2025)  
Subject to variation dependent on workload
3. Classification : General Central Services - Group 'B'  
Non-Gazetted - Non-Ministerial
4. Level in the Pay Matrix : Level - 6 (₹35400-₹112400) in the Pay Matrix
5. Whether selection post or non-selection post : Selection
6. Age limit for direct recruits : *Not exceeding 30 years (Relaxable for Government servants upto 5 years in accordance with the orders or instructions issued by the Government)*

*Note: The crucial date for determining the age-limit shall be as advertised by the Competent Authority.*

7. Educational and other qualifications required for direct recruits : Essential:  
(i) A Diploma in Automobile Engineering (3 years course) or Diploma in Mechanical Engineering (3 years course) from recognized University / Institution;  
(ii) Driving License authorizing to drive motor cycle with gear, light motor vehicle and transport (medium and heavy) motor vehicles.  
(OR)  
(i) A Bachelor's Degree in Automobile or Mechanical Engineering from recognized University / Institute.  
(ii) Driving License authorizing to drive motor cycle with gear, light motor vehicle and transport (medium and heavy) motor vehicles.
8. Whether age and educational qualifications prescribed for direct recruits will apply in the case of promotees : Age: No.  
Educational Qualification: Yes.  
As indicated in column No.11.
9. Period of probation, if any : Two years for direct recruitment.

*Note: Direct recruits would be required to successfully complete a mandatory induction training of at least two weeks duration, as prescribed by the competent authority, for completion of probation.*

10. Method of recruitment, whether by direct recruitment or by promotion or by deputation/absorption and percentage of the vacancies to be filled by various methods : (i) 70% by promotion failing which by deputation (ISTC), and failing both which by direct recruitment.  
(ii) 30% by direct recruitment.
11. In case of recruitment by promotion/ deputation/ absorption, grades from which promotion/deputation/ absorption is to be made : Promotion:  
Junior Engineer / Assistant Motor Vehicles Inspector in Level-6 in the Pay matrix with 3 year service in the grade rendered after appointment thereto on a regular basis and successfully completed the Departmental Training Programme (for a period of two months) conducted by the Transport Department, Government of Puducherry.

Note-1: For existing incumbents holding the feeder posts on regular basis on the date of notification of these rules, the requirement of successful completion of training for promotion shall be either before promotion or within a period of one year from the date of promotion.

Note-2:

Where juniors who have completed their qualifying eligibility service are being considered for promotion, their seniors would also be considered provided they are not short of the requisite qualifying/eligibility service by more than half of qualifying/eligibility service or two years, whichever is less, and have successfully completed their probation period for promotion to the next higher grade along with their juniors who have already a completed such qualifying/eligibility service.

Deputation (ISTC):

Officers of the Central Government/State Governments/Union Territory or Autonomous or Statutory Organization or Public Sector Undertaking or Recognized University or Research Institution:-

(a) (i) holding analogous posts on regular basis in the parent cadre or Department; or

(ii) with six (6) years regular service in the posts in the pay level-5 in the pay matrix in parent cadre or Department;

(b) Possessing the educational and other qualifications prescribed for direct recruits under column-7.

Note-1: The departmental officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, the deputationists shall not be eligible for consideration for appointment by promotion.

Note-2: Period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization / Department of the Central government shall ordinarily not to exceed 3 years. The maximum age limit for appointment by deputation shall be not exceeding 56 years as on the closing date of receipt of applications.

12. If a Departmental Promotion Committee exists, what is its composition : *Group 'B' Departmental Promotion Committee/Departmental Confirmation Committee:-*
1. The Chief Secretary to Government of Puducherry -- Chairman
  2. The Secretary to Government (Transport) -- Member
  3. The Transport Commissioner -- Member
13. Circumstances in which Union Public Service Commission is to be consulted in making recruitment / promotion : Consultation with UPSC is not necessary.
