The Ministry of Road Transport and Highways vide reference 7th cited issued an advisory to treat the validity of various documents such as validity of fitness, Permit (all types), Learner's Licence, Driving License, Registration or any other concerned documents upto 31st December, 2020. A circular of this Department referred (6th), therein the validity of the fitness, Permit (all types), Driving Licence, Registration or any other concerned documents was extended upto 30th September 2020. Now, it is further extended and the validity of the documents may be treated as valid upto 31st December 2020.

In this regard, it is advised to all the enforcement authorities to treat the validity of all the above said documents which had expired since 1st February 2020 or would expire by 31st December 2020, the same may be treated to be valid till 31st December 2020
