CIRCULAR

Sub: Transport Department – Conversion of 'Private Service Vehicles permits' of Educational Institutions / Educational Trusts as 'Educational Institution Vehicle' Permits and Compulsory fitment of Vehicle Location Tracking Device and Emergency Button in all the public service vehicles on or before 31st March 2018 – Instructions – Issued – Reg.

Ref: (i) This Department's Circular of even No., dated 10.11.2017 (ii)G.S.R.1095(E) Notification dated 28.11.2016 of Ministry of Road Transport and Highways, New Delhi (Copy enclosed).

The Educational Institutions / Educational Trusts having Private Service Vehicle Permits for their educational activities were requested to convert their permits as "Educational Institution Permits" vide Circular cited under reference (i) above. Most of the vehicle owners have not so for converted their permits to the concessional category of Educational Institution Permit. It is informed that if the conversion for these vehicles is not made on or before 31st March, 2018, the yearly tax will levied at the rate applicable for Private Service Vehicle permit other than educational institution category with effect from 1st April, 2018. Hence, the Educational Institutions / Trusts having Private Service Vehicle permits for Educational Institution purpose, if not converted as Educational Institution Vehicle permits, so for, are requested to apply for the conversion alongwith necessary fees, valid records of the vehicle and self-attested copies of required documents before 15th March, 2018.

2. It is further informed to the vehicle owners that as per the Notification cited under reference (ii) above, provision of 'Vehicle Location Tracking Device' and 'Emergency Button' are required to be mandatorily fixed in the Educational Institution vehicles from 01.04.2018 onwards. The specifications, testing and certification of the Vehicle Location Tracking Device and Emergency Button shall be in accordance with AIS-140: 2016, as amended from time to time, till such time the corresponding BIS specifications are notified under the Bureau of Indian Standards Act, 1986 (63 of 1986). The Vehicle Location Tracking Device and Emergency Button shall be fitted by the manufacturer or their dealer or the respective operator, as the case may be.

- 3. Accordingly in compliance to the above notification and rule 125-H of C.M.V.R. 1989 the vehicle / vehicles of the permit holder shall be equipped with or fitted with 'Vehicle Location Tracking Device' and one or more 'Emergency Buttons' on or before 31.03.2018, positively. Non compliance shall attract action as per the extant Act and Rules.
- 4. As fixing Vehicle Location Tracking Device and Emergency Buttons is mandatory in Private Service Vehicles and Educational Institution Vehicles from 01.04.2018 onwards no application for issue of Fitness Certificate will be entertained to the vehicles produced without fitment of Vehicle Location Tracking Device and Emergency Button from 01.04.2018 onwards.

G.S.R. 1095(E).—Whereas the draft rules further to amend the Central Motor Vehicles Rules, 1989, were published, as required under sub-section (1) of section 212 of the Motor Vehicles Act, 1988 (59 of 1988), vide notification of the Government of India in the Ministry of Road Transport and Highways number G.S.R. 478 (E), dated the 2rd May, 2016 in the Gazette of India, Extraordinary, Part II, section 3, sub-section (i), inviting objections and suggestions from affected persons before the expiry of the period of thirty days from the date on which copies of the Gazette containing the said notification were made available to public;

And whereas, copies of the said Gazette notification were made available to the public on the 2nd May, 2016;

. And whereas, the objections and suggestions received from the public in respect of the said draft rules have been considered by the Central Government.

Now, therefore, in exercise of the powers conferred by clause (k) of sub-section (1) of section 110 of the Motor Vehicles Act, (59 of 1988), the Central Government hereby makes the following rules further to amend the Central Motor Vehicles Rules, 1989, namely:—

- 1. (1) These rules may be called the Central Motor Vehicles (Twentieth Amendment) Rules, 2016.
 - (2) They shall come into force on the 1st day of April, 2018.
- 2. In the Central Motor Vehicles Rules, 1989, after rule 125 G, the following rule shall be inserted, namely,-

"125 H. Provision of vehicle location tracking device and emergency button.-

(1) All public service vehicles, as defined under clause (35) of section 2 of the Act, shall be equipped with or fitted with vehicle location tracking device and one or more emergency buttons:

Provided that this rule shall not apply to the following category of vehicles, namely:-

- (i) two wheelers;
- (ii) E-rickshaw;
- (iii) three wheelers; and
- (iv) any transport vehicle for which no permit is required under the Act.
- (2) The specifications, testing and certification of the vehicle location tracking device and emergency button referred to in sub-rule (1) shall be in accordance with AIS-140: 2016, as amended from time to time, till such time the corresponding BIS specifications are notified under the Bureau of Indian Standards Act, 1986 (63 of 1986).
- (3) The vehicle location tracking device and emergency button referred to in sub-rule (1) shall be fitted by the manufacturer or their dealer or the respective operator, as the case may be, in accordance with AIS-140: 2016, as amended from time to time, till such time the corresponding BIS specifications are notified under the Bureau of Indian Standards Act, 1986."
