NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, read with the Notification No. F. 5/4/65-GP, dated the 11th January, 1965 of the Government of India, Ministry of Home Affairs, New Delhi and in supersession of the notification issued in G.O. (Tr.), dated 28th July 1994 published in the Supplement to the Gazette No. 37 of the 13th September 1994, save as respects things done or omitted to be done before such supersessions and in pursuance of the orders issued in G.O. Ms. No. 8/2016 (Tr. Sectt.), dated 7-10-2016 of the Transport Secretariat, Government of Puducherry, the Lieutenant-Governor, Puducherry hereby makes the following rules regulating the method of recruitment to the post of Enforcement Assistant Group 'C' - Non-Gazetted (Technical) in the Transport Department, Government of Puducherry, namely:-

- 1. Short title and commencement.— (1) These rules may be called the Government of Puducherry, Transport Department, Recruitment Rules to the post of Enforcement Assistant, 2016.
 - (2) They shall come into force on and from the date of their publication in the Official Gazette.
- 2. Number of posts, its classification, Pay Band and Grade Pay/Pay Scale.— The number of the said posts, its classifications and the Pay Band and Grade Pay/Pay Scale attached thereto, shall be as specified in the columns (2) to (4) of the Schedule annexed hereto.
- 3. Method of recruitment, age-limit and other qualifications.— The method of recruitment to the said posts, age-limit, qualifications and other matters relating thereto, shall be as specified in columns (5) to (13) of the said Schedule.
 - 4. Disqualifications. No person, -
 - (a) who has entered into or contracted a marriage with a person having a spouse living; or
- (b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Lieutenant-Governor may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

- 5. Power to relax.— Where the Lieutenant-Governor is of the opinion that it is necessary or expedient so to do, he may, by order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.
- 6. Saving.— Nothing in these rules shall affect the reservations, relaxation in upper age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Government from time to time in this regard.

Between 18 and 30 years (Relaxable for Government servants up to 40 years in accordance with the orders or instructions issued by the Central Government, provided such Government Servants are working for not less than 3 years in posts which are in the same line or allied cadres and where a relationship can be established that the services rendered by them in the Department will be useful for efficient discharge of duties in the posts for which selection is made).

Note: (1) In the case of recruitment made through advertisement, the crucial date for determining the age-limit shall be the closing date for receipt of applications.

Note: (2) In the case of recruitment made through the Employment Exchange, the crucial date for determining the age-limit shall, in each case, be the last date up to which the Employment Exchanges are asked to submit the names.

7. Educational and other qualifications required: (i) for direct recruits.

- Passed 10th class examination under 10+2 system of education or its equivalent;
- (ii) National Trade Certificate/National Apprenticeship Certificate issued by the Ministry of Labour, Government of India in the trade of Automobile Engineering/Mechanical (Motor Vehicle) with one year experience in a reputed organization/workshop;
- (iii) Must possess Light Motor Vehicle Driving Licence.

(or)

- (i) Diploma in Automobile/Mechanical Engineering.
- (ii) Must possess Light Motor Vehicle Driving Licence.

Note: The qualification regarding experience is relaxable at the discretion of the competent authority in the case of candidates belonging to Scheduled Castes or Scheduled Tribes if, at any stage of selection, the competent authority is of the opinion that sufficient number of candidates from these communities possessing the requisite experience are not likely to be available to fill up the vacancies reserved for them.

8. Whether age and educational qualifications prescribed: Not applicable for direct recruits will apply in the case of promotees.

9. Period of probation, if any

Two years

10. Method of recruitment, whether by direct : recruitment or by promotion or by deputation/ absorption and percentage of the vacancies to be filled by various methods.

Note: (1) The officials holding the posts of Mechanic, Welder, Welder (Tinkering), Electrician, Carpenter, Upholsterer and Machinist on the date of notification of these rules shall be deemed to have been appointed to the post at the initial constitution.

Note: (2) Vacancies caused by the incumbent being away on deputation or long illness or study leave or under other circumstances for a duration of one year or more may be filled on deputation basis from officials of Puducherry Administration:-

- (a) holding analogous posts on regular basis in the parent cadre/department; and
- (b) possessing the qualifications and experience prescribed for direct recruitment under column (7).

[Period of deputation (ISTC) including the period of deputation (ISTC) in another ex-cadre post held immediately preceding this appointment in the same or some other organization or departments of the Central/ State/Union Territory Governments shall ordinarily not exceed 3 years. The maximum age-limit for appointment by deputation shall be not exceeding 56 years as on the closing date of receipt of applications]
