NOTIFICATION

In exercise of the powers conferred by section 68(5) and section 96 of the Motor Vehicles Act, 1988 (Central Act No. 59 of 1988), the Lieutenant-Governor, Puducherry hereby makes the following amendment to the Puducherry Motor Vehicles Rules, 1989, the draft of the same having been pre-published in the notification issued in G.O. Ms. No. 40/2014/Sectt., dated 3-11-2014 by the Transport Secretariat, Puducherry and published in the Extraordinary Gazette, Part-II, No. 29, dated the 7th November 2014

as required under sub-section (1) of section 212 of the said Act and the objections and suggestions received in response thereto having been considered, namely :-

AMENDMENT

1. Short title and commencement.— (1) These rules may be called the Puducherry Motor Vehicles (Amendment) Rules, 2015.

(2) They shall come into force on and from the date of their publication in the official gazette.

2. Amendment of rule 3.— In the Puducherry Motor Vehicles Rules (hereinafter referred to as the said rules), for sub-rule (1) of rule 3, the following shall be substituted, namely:—

"3. Appointment of Licensing Authorities.— (1) For the purpose of Chapter-II of the Act, the Regional Transport Officer shall be the Licensing Authority within his jurisdiction and in regions where there is no Regional Transport Officer, the Regional Administrator of the region shall be the Licensing Authority in their respective jurisdictions.".

3. Amendment of rule 15.— In the said rules, for sub-rule (1) of rule 15, the following shall be substituted, namely:-

"15. Appointment of Licensing Authorities.— (1) For the purpose of Chapter-III of the Act, the Regional Transport Officer shall be the Licensing Authority within his jurisdiction and in regions where there is no Regional Transport Officer, the Regional Administrator of the region shall be the Licensing Authority in their respective jurisdictions.".

4. Amendment of rule 29.— In the said rules, for rule 29, the following shall be substituted, namely:-

"29. Appeal.— Any person aggrieved by any order of the Licensing Authority under this Chapter may, within thirty days of the date of receipt of such order appeal to the Transport Commissioner.".

5. Amendment of rule 31.— In the said rules, for sub-rule (1), the following shall be substituted, namely:-

"31. Appointment of Registering Authorities.— (1) For the purpose of Chapter-IV of the Act, the Regional Transport Officer shall be the Registering Authority within his jurisdiction and in regions where there is no Regional Transport Officer, the Regional Administrator of the region shall be the Registering Authority in their respective jurisdictions.".

6. Amendment of rule 50.— In the said rules, for rule 50, the following shall be substituted, namely:-

"50. Appeal.— Any person aggrieved by any order of the Registering Authority under this Chapter may within thirty days of the date of receipt of such order appeal to the Transport Commissioner.".

7. Amendment of rule 54.— In the said rule 54, after sub-rule (4), the following sub-rules shall be inserted, namely:-

"(5) Without prejudice to the powers conferred under the statutory prescription, the following powers of STA may be delegated to the officials designated as Special Secretary, Deputy Secretary and Assistant Secretaries in the regions of Puducherry, Karaikal, Mahe and Yanam, in respect of the following classes of transport vehicles only, namely:-

Provided that the powers to issue/cancellation of permit with respect to H.M.V. (OB), M.M.V. (OB), L.M.V. (OB), Auto-Rickshaw and any other category of vehicle not delegated above, shall be retained by the State Transport Authority. Provided also that in order to keep the State Transport Authority apprised about the details of all permits issued, periodical report of the permits issued by various authorities of the STA viz., Special Secretary (STA), Deputy Secretaries (STA) and Assistant Secretaries (STA) and other related details shall be submitted to the Secretary (STA) for information and necessary ratification as the case may be.

(6) The Secretary, State Transport Authority may by specific order delegate powers to the designated authority in the checkpost to issue special permits under section 88 (8), temporary permits under section 87 and permit collection of entry tax for other State vehicles as per the rules.".

8. In rule 104 of the said rules, after sub-rule (4), the following sub-rule shall be inserted, namely:-

"(5) Any staff of the Transport Department employed in a checkpost may at any time when a transport vehicle is near or at the checkpost, call upon the driver of the vehicle to stop the vehicle and to keep it at rest for such time as may be necessary to enable him to make a reasonable examination of the vehicle, and verify the permit, registration certificate, insurance certificate and fitness certificate of the vehicle:

Provided the inspection shall be conducted under the supervision of the designated authority in terms of the statutory prescriptions.".

9. In the said rules, in rule 247, for the words "the Deputy Transport Commissioner shall be the Assistant Secretary to the State Transport Authority" the words "the Deputy Transport Commissioner shall be the Deputy Secretary to the State Transport Authority" shall be substituted.

10. In the said rules, after rule 247, the following rules shall be inserted, namely:-

"247-A. Designation of authorities.— The following officers shall be designated as members of the State Transport Authority with delegated powers to function as Special Secretary/Deputy Secretary and Assistant Secretary in the regions of Puducherry, Karaikal, Mahe and Yanam. 1
