NOTIFICATION

In exercise of the powers conferred by section 96 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988), the Lieutenant-Governor of Pondicherry, hereby makes the following amendment to the Pondicherry Motor Vehicles Rules, 1989; the draft notification of the same having been pre-published in the Notification issued in G. O. Ms. No. 17/99-Wel. (Tr.), dated 7th June 1999 of the Chief Secretariat (Transport), Pondicherry

and published in the Extraordinary Gazette Part-II, No. 32, dated 6th July 1999, as required under sub-section (i) of section 212 of the said Act and no objections and suggestions having been received in response thereto, namely :—

1. *Short title and commencement.*—(1) These rules may be called the Pondicherry Motor Vehicles (Amendment) Rules, 1999.

(2) They shall come into force on and from the date of their publication in the official gazette.

2. *Amendment of rule 63 (2).*—In sub-rule (2) of rule 63 of the Pondicherry Motor Vehicles Rules, 1989 (hereinafter referred to as the said rules),—

(1) for the item (viii) and the entries relating thereto, the following shall be substituted, namely: —

“(viii) (a) in the case of taxis for issue of special permits for a period not exceeding 7 days .. Rs. 50.00;

(b) in the case of Light Motor Vehicles (Omni Bus) and Maxi Cabs .. Rs. 50.00; and

(c) for the other categories .. Rs. 100.00”.

(2) for the item (ix) and the entries relating thereto, the following shall be substituted, namely: —

“(ix) (a) in the case of taxis for issue of special permits for a period exceeding 7 days .. Rs. 75.00;

(b) in the case of Light Motor Vehicles (Omni Bus) and Maxi Cabs .. Rs. 90.00;

(c) for other categories .. Rs. 150.00”.

3. *Amendment of rule 78 (5).*—In sub-rule (5) of rule 78 of the said rules, for clause (i), the following shall be substituted, namely :—

“(i) If the State Transport Authority is satisfied that the transfer of permit may properly be made it shall call upon the holder of the permit in writing to surrender the permit

within seven days of the receipt of the order and shall likewise call upon the person to whom the permit is to be transferred, transfer to pay the following fees in respect of the carriages or vehicles indicated against each, namely :—
