ORDER

Sub: Retrofitment Speed Limiting Device (SLD) / Speed Governor and integration of retrofitted data with the VAHAN database – Guidelines – Issued - Reg.

Ref: 1. G.O.Ms.No.20/Sectt./2025, dated 07-10-2015 of the Transport Department, Puducherry.

 Guidelines for fitment of SLD No.7361/TD/RTO(P)/2017, dt. 26-12-2017 of the Transport Department, Puducherry.

In continuation of the order issued in reference cited above, the following guidelines for fitment and inspection of Speed Limiting Device in the vehicles are given below:

- (i) The Speed Limiting Device (SLD) shall be type approved by any of the test agencies authorized under Rule 126 of CMVR,
 - (a) Valid Type Approval Certificate or COP as prescribed in AIS-037/2004, as amended from time to time.
 - (b) Performance test report on different vehicle models and their variants approved as per AIS-018/2001 as amended from time to time.
- (ii) Speed Limiting Device (SLD) shall conform to Electromagnetic Compatibility (EMC) requirements as per AIS-004(Part 3)/ 1999 as amended from time to time.
 - NIC will issue a unique username and password to each approved Speed Limitation Device (SLD) manufacturer for uploading the Type approval data on VAHAN Portal.
 - Speed Limitation Devices (SLD) Manufacturers should upload the data in VAHAN portal as indicated below:
 - a) Speed Limitation Device (SLD) / Speed Governor make and model
 - b) Type Approval Certificate (TAC) and / or Conformity of Production Certificate (COP) as applicable
 - c) Vehicle model name
 - d) Unique Identification number as per following format:

- All Speed Limitation Device (SLD) / Speed Governor Manufacturers should upload the production stock data of the type approved Speed Limitation Device (SLD) / Speed Governor on VAHAN portal.
- 4. SLD manufacturers should put the unique identification number (16 digit) on each speed Limitation Device (SLD) / Speed Governor.



- All Speed Governor Manufacturer(s) shall ensure that registration number of that particular vehicle is engraved on the type approved SLD at the time of installation on vehicle by their SLD fitment dealers & Retrofitment centre.
- 6. All the above requirements are waived in cases where speed limiting function is already provided for at the time of manufacture of the vehicle.
- (iii) Every Speed Limiting Device (SLO) component(s) to be fitted shall be verified for the markings (may be in the shape of sticker having barcode) containing following information-
 - (a) The trademark/ manufacturer emblem.
 - (b) The serial number assigned by the manufacturer.
 - (c) Reference Alphanumeric number of the type approval shall be indicated by a Mark having six characters allotted by the test agency as per AIS-037/2004 as amended from time to time.
- (iv) A sticker of standardized size of 100mmX60mm has to be fixed on the left upper side of front windscreen from inside indicating the set speed limit in a circle of 55mm and the balance space to be used for the information as mentioned in (iii) above. Destructible sticker containing the information of marking as mentioned in (iii) above shall be fixed on the windscreen for quick audit purposes without reference to RC book.
- (v) The maximum speeds set by the SLD manufacturers or Retrofitment Centre should be as per the orders / guidelines issued in this regard by the Government of UT of Puducherry from time to time.
- (vi) The manufacturer or their authorized dealer(s) or their authorized retrofitment center(s) shall ensure that the speed limiting device fixed in the vehicle limits the maximum speed of respective type/category of vehicle as notified by the Govt. of Puducherry from time to time and has to be sealed at the appropriate points by the manufacturer(s) or their authorized dealer(s) or their authorized retrofitment center(s) as the case may be.
- (vii) No person shall open, tamper or otherwise interfere with the seal on Speed Limiting Device. And also, the driver or owner shall not drive or cause to drive the vehicle in public place if a vehicle is not fitted with SLD or the seal of which is tampered with. The vehicle owner will be responsible for any tampering of the speed limiting device. The officials concerned during enforcement found any such tampering of the speed limiting device, shall initiate for appropriate action against the owner.
- (viii) Each Speed Limiting Device manufacturer will be required to maintain a Management Information System (MIS) to keep record of each Speed Limiting Device (SLD) installed on the vehicle for audit/quick retrieval at any time.
- (ix) The manufacturer and the Retrofitment agency/dealer shall submit their monthly report to the registering authority in writing or through e-mail rto-td.py@gov.in regarding the Sale and fitment of SLD as the case may be, in the UT of Puducherry before 5th day of next month. The manufacturer or Retrofitment agency/dealer are liable for action including
