**NOTIFICATION**

In exercise of the powers conferred by section 96 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988), the Lieutenant-Governor, Puducherry hereby makes the following rules to further amend the Puducherry Motor Vehicles Rules, 1989, the draft of the same having been pre-published in the Notification issued in G.O.Ms.No.13/Tr.Sectt./2011 dated the 14<sup>th</sup> June, 2011 of the Transport Secretariat and published in the Extra-Ordinary Gazette Part-II No.15, dated the 20<sup>th</sup> June, 2011 as required under sub-section (1) of section 212 of the said Act and the objections and suggestions received in response thereto having been considered; namely:-

**1. Short title and commencement.** - (1) These rules may be called the Puducherry Motor Vehicles(Amendment) Rules, 2011.

(2) They shall come into force on and from the date of their publication in the Official Gazette.

**2. Insertion of new rule 252.** - In the Puducherry Motor Vehicles Rules, 1989, after rule 251, the following rule shall be inserted, namely:

**"252 (1) Levy of Service Charges.** - There shall be levy of Service Charges for the services rendered by the officers and authorities at the rates specified in the Table below, which shall be paid in addition to the fees payable under the Act along with fees/tax payable.
