NOTIFICATION

The draft of the following Rules further to amend the Puducherry Motor Vehicles Rules, 1989, which the Lieutenant Governor, Puducherry proposes to make in exercise of the powers conferred by section 211 of the Motor Vehicles Act, 1988(Central Act 59 of 1988), is hereby published as required under sub-section(1) of Section 212 of the said Act for information of all persons likely to be affected thereby and notice is hereby given that the said draft rules will be taken into consideration on the expiry of 7 days from the date of publication of this notification in the Official Gazette.

Any objection or suggestion which may be received from any person by the Government of Puducherry in respect of the said draft rules within the period specified above will be considered by the Government. The objections or suggestions should be addressed to the Special Secretary to the Government(Transport), Chief Secretariat, Puducherry.

DRAFT RULES

1. Short title and commencement:-

- (1) These rules may be called the Puducherry Motor Vehicles(Amendment) Rules, 2011.
- (2) They shall come into force on and from the date of their publication in the Official Gazette.

2. Insertion of new rule 252:-

In the Puducherry Motor Vehicles Rules, 1989, after Rule 251, the following rule shall be inserted, namely:

"252 (1) Levy of Service Charges":- There shall be levy of Service Charges for the services rendered by the officers or authorities at the rates specified in the table below which amount shall be paid in addition to the fees payable under the Act along with fees/tax payable.
