In exercise of the powers conferred by clause (c) of sub-section (1) of section 4 of the Puducherry Motor Vehicles Taxation Act, 1967 (Act No. 5 of 1967), the Lieutenant-Governor, Puducherry hereby makes the following alterations to the Schedule-II of the Act with effect from the date of publication in the Official Gazette, namely:-

**ALTERATIONS**

2. Motor vehicles plying for hire and used for the transport of passengers and in respect of which permits have been issued under the Motor Vehicles Act:-



“(iv) (a) Reserve Stage Carriage or Spare Bus (to carry more than six persons excluding the driver and the conductor) when operated as “Contract Carriage” on special occasion under special permit. ₹ 5 per person per day”

In the Puducherry Motor Vehicles Taxation Act, 1967 (Act No. 5 of 1967) in Schedule-II, in item 3 below sub-item(c), the following shall be added as (c) (a), namely:-

“(c) (a) Reserve Stage Carriage or Spare Bus (to carry more than six persons excluding the driver and the conductor) when operated as “Contract Carriage” on special occasion under special permit. ₹ 5 per person per day”
