#### NOTIFICATION

In exercise of the powers conferred by section 96 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988), the Lieutenant-Governor, Puducherry hereby makes the following amendment to the Puducherry Motor Vehicles Rules, 1989, the draft of the same having been pre-published in the notification issued in G.O. Ms. No. 02/2017/Tr. Sectt., dated 12-04-2017 and published in the Extraordinary Gazette-Part-II,

No. 27, dated 17-05-2017 as required under sub-section (1) of section 212 of the said Act, and no objections and suggestions having been received in response thereto, namely:-

#### AMENDMENT

1. *Short title and commencement.*— (1) These rules may be called the Puducherry Motor Vehicles (Amendment) Rules, 2017.

(2) They shall come into force on and from the date of their publication in the Official Gazette.

2. *Amendment of Rule 54.*— (a) In the Puducherry Motor Vehicle Rules, 1989 (hereinafter referred to as the said rules), in sub-rule (1) of rule 54, in the second proviso to clause (vi), after the existing item (d), the following shall be inserted, namely:-

"(e) Educational Institution Vehicles".

(b) In the said rules, for the existing item (c) of sub-rule (5) of rule 54, the following shall be substituted, namely:-

"(c) Private Service Vehicles/Educational Institution Vehicles:

1	Grant/Refusal/Transfer/Cancel of Private Service Vehicle/Educational Institution Vehicle permit.	Special Secretary (STA), Karaikal/Deputy Secretary (STA), Puducherry, Mahe and Yanam.
2	Renewal/Replacement/Surrender/Alteration/Change of address of Private Service Vehicle/Educational Institution Vehicle permit.	Assistant Secretary (STA), Puducherry, Karaikal, Mahe and Yanam."

3. *Amendment of Rule 60.*— In the said rules, after the clause (vi) of sub-rule (1) of rule 60, the following clause shall be inserted, namely:-

"(vii) Educational Institution Vehicle Permit      Form P.E.I.V.A"

4. *Amendment of Rule 61.*— In the said rules, after the clause (viii) of sub-rule (1) of rule 61, the following clause shall be inserted, namely:-

"(ix) Educational Institution Vehicle Permit      Form P.E.I.V."

5. *Amendment of Rule 63.*— In the said rules, after the item (x) of sub-rule (1) of rule 63, the following shall be inserted, namely:-

"(xi) For the grant and the renewal of Educational      2,000  
Institution Vehicle Permit.

(xii) For endorsement in the permit for conversion      500  
of existing Private Service Vehicle Permit of  
Educational Institutions/Trusts/ Societies as  
Educational Institution Vehicle Permit, in  
the permit.

*Note:* (1) For the purposes of Educational Institution Vehicle Permit, the Vehicles of Educational Institutions and Educational Trusts running Educational Institutions approved by a Competent Authority shall be included in the Educational Institution Vehicle Permit category.

*Note:* (2) The existing permit holders of Private Service Vehicles of Educational Institutions shall apply to the Competent Authority to grant the Educational Institution Vehicle Permit, in writing, alongwith the fees prescribed, for conversion of the permit as Educational Institution Vehicle Permit and endorsement in the permit."

6. Insertion of Form - P.E.I.V.A. : After Form - P.Pr.S.V.A. the following Form shall be inserted, namely:-
