ORDER:

The following notification shall be published in the official Gazette of Pondicherry:-

NOTIFICATION

In exercise of the powers conferred by sub-clause (i) of sub-section (1) of section 67 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988) and in supersession of the directions issued in G.O. Ms. No. 33/91-Wel(Tr), dated 27.6.1991, save as respects things done or omitted to be done before such supersession, the Lieutenant-Governor, Pondicherry hereby issues the following directions regarding the fixing of fares for autorickshaws and ordinary taxis for which permits have been issued by the State Transport Authority, namely:-

TERMS & CONDITIONS

1. The State Transport Authority, Pondicherry is hereby directed to fix subject to the conditions specified below the fares for autorickshaws and ordinary taxicabs for which permits have been issued by the said authority at the rates not exceeding the following in the whole of the Union territory of Pondicherry, namely:-

(1) Autorickshaws:-

(a) Day service (5.00 A.M. to 10.00 P.M.)

(A) Rate in plains:

- (i) For each kilometre
- (ii) Minimum charge
- (iii) Detention charge

Rupees two and paise twenty only  
Rupees four and paise forty only  
Ten paise for every ten minutes or part thereof

Note: The meter shall be so set that it shows Rupees four and paise forty only till the completion of two kilometres and then move at the rate of ten paise for every one-fourth second of a kilometre.

(B) Rate in hilly sections:

An additional charge of 25% over and above the aforesaid rates shall be charged.

(b) Night service (10.00 P.M. to 5.00 A.M.)

An additional charge of 50% of the above rates (rounded off to the nearest ten paise) shall be charged.

(2) Ordinary Taxis:

(a) Day service (5.00 A.M. to 10.00 P.M.)

(1) Rate in plains:

- (i) For each kilometre
- (ii) Minimum charge
- (iii) Detention charge

Rupees three and paise forty only.  
Rupees six and paise eighty only.  
Ten paise for every five minutes or part thereof

Note: The meter shall be so set that it shows Rupees six and paise eighty only till completion of two kilometres and then move at the rate of ten paise for every one-fourth of a kilometre.



(D) Rate in Chat section:

An additional charge of 25% over and above the aforesaid rates shall be charged.

(b) Night service (10.00 P.M. to 5.00 A.M.):

An additional charge of 50% of the above rates (rounded off to the nearest ten paise) shall be charged.

Explanation: The expression "Chat section" shall mean such areas as may be notified for this purpose by the Government in the official Gazette from time to time.

2. The above rates shall come into force with immediate effect.

3. A period of three months shall be allowed for the autorickshaws and ordinary taxis to get the meter recalibrated in terms of the above rates.

4. Pending recalibration of the meters, the vehicles shall carry conversion tables approved by the State Transport Authority to facilitate collection of fares at the above rates.

NOTIFICATION

In exercise of the powers conferred by sub clause(1) of clause (d) of sub-section (1) of section 67 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988) and in partial modification of the notification issued under G.O.Ms.No.47/91/WE1(Tr.), dated 22nd October, 1991 and published in Para-1 of the Extraordinary Gazette No.131, dated 24th October 1991, in so far as it relates to Autorickshaws, the Lieutenant-Governor, Pondicherry issued the following directions regarding the fixing of fares for Autorickshaws for which the permits have been issued by the State Transport Authority, Pondicherry and for the said purpose makes the following amendment to the said notification, namely:-

AMENDMENT

1. In the said notification, for sub para-graph(1) of Paragraph-1, under the heading "Directions", the following shall be substituted, namely:-

"(1) Autorickshaws:-

(a). Day Service (6.00 A.M. to 10.00 P.M.)

(A). Rate in plains:

- (i) For each Kilometre : Rupees Four only
- (ii) Minimum charges upto 2 km. : Rupees eight only
- (iii) Detention Charges : 50 paise for every half hour or part thereof.

Note: The meter shall be so set that it shows rupees eight only till the completion of 2.00 KMS. and then move at the rate of 40 paise for every 100 mtrs. or the 1/10 of a Kilometre.

(b) Night Service (10.00 P.M. to 5.00 A.M)  
An additional charges of 50% of the above rates (rounded off to the nearest ten paise) shall be charged".

- 2. The above rates shall come into force with immediate effect.
- 3. A period of 15 days shall be allowed for the autorickshaws to get the meters recalibrated in terms of the above rates.

4. Pending recalibration of the meters, the vehicles shall carry conversion tables approved by the State Transport Authority to facilitate collection of fares at the above rates.



- (iii) Detention charges : Rupees ten for every 30 minutes

Note: The meter shall be so set that it shows rupees twenty only till the completion of 2.00 kms. and then move at the rate of one rupee for every 100 mtrs. or 1/10 of a kilometer.

**(b) Night Service (10.00P.M. to 5.00 A.M):**

In addition to the above rate, an additional charge of 50 per cent of the above rate.”

2. The above rates shall come into force with immediate effect.
3. A period of 30 days shall be allowed for the auto-rickshaws to get the meters recalibrated in terms of the above rates.
4. Pending recalibration of the meters, the vehicles shall carry conversion tables approved by the Secretary, State Transport Authority, Puducherry to facilitate collection of fares at the above rates.


Note: The meter shall be so set that it shows rupees twenty five only till the completion of 1.8 Kms. and then move at the rate of one rupee for every 100 mts. or 1/10 of a kilometer.

**(b) Night Service (10.00 P.M. to 5.00 A.M.)**

In addition to the above rate, an additional charge of 50 per cent of the above rate".

2. The above rates shall come into force with immediate effect.
3. A period of 60 days shall be allowed for the autorickshaws to get the meters recalibrated in terms of the above rates from the date of issue of this G.O.
4. Pending recalibration of the meters, the vehicles shall carry conversion tables approved by the Secretary, State Transport Authority, Puducherry to facilitate of fares at the above rates.
5. After interaction with the stakeholders and after taking into consideration of the cost input in running an autorickshaw, the geographical area of Puducherry, approximate distance an auto is capable of plying in Puducherry and also the consumer price index in Puducherry and any other relevant input the Government may revise fare for autorickshaws before the end of October every year.
