**NOTIFICATION**

WHEREAS, the Government has proposed to introduce E-rickshaw Scheme in Puducherry and framing procedural guidelines for licensing/registration/fitness/grant of permit of E-rickshaw so as to provide safe and affordable transport to senior citizens, women, children and infirm people for last mile connectivity from bus stops, railway stations to their houses by promoting e-rickshaws to be operated by poor unemployed youth.

AND WHEREAS, it is decided by the State Transport Authority in its meeting held on 17.04.2015 vide Agenda 2.2 of the Minutes, for issue of permits for E-rickshaw for the area East from M.G. Road and within the Boulevard limit on pilot basis.
