2. The Council shall perform the following functions:-
- (i) To advise the Government on all matters pertaining to Planning and Co-ordination of policies, practices and standards of Road Safety in the Road Transport sector;
  - (ii) To formulate and recommend Road Safety Programmes to the Road Safety – High Level Committee and District/Regional Road Safety Committee.
  - (iii) To suggest areas for Research and Development, to improve Road Safety aspects including maintenance of Statistics and their analysis; and
  - (iv) To generally oversee and monitor Road Safety scenario through Road Safety – High Level Committee and District/Regional Road Safety Committee and to assign any related work to these Committee.
3. The Non-Official Members shall hold office for a period of two years.
4. The Council shall decide the procedure and methodology to be adopted for its functioning.
5. The Council shall meet ordinarily once in six months.
6. This notification shall come into force with immediate effect.
