#### NOTIFICATION

In exercise of the powers conferred under clause (iii) of proviso to rule 108 of the Central Motor Vehicles Rules, 1989 and in supersession of G.O.Mis.No.36/2004(Tr.), dated 24.09-2004 of Welfare Secretariat, Puducherry, save as respects things done or omitted to be done before such supersession, the Lieutenant-Governor, Puducherry is pleased to specify that consequent to the directions of the Hon'ble Supreme Court of India in SLP ( C ) No. 25237/2010 read with the SLP ( C ) No. 23984 /2010 the display of red lights etc., by the vehicles shall be regulated in the following manner:

- 2. The vehicles carrying the following high dignitaries are permitted to use red light within the jurisdiction of the Union Territory of Puducherry.
- a) Red Light with Flasher:
  - (i) Lieutenant Governor
  - (ii) Chief Minister
  - (iii) Speaker
- a) Red Light without Flasher;
  - (i) All Ministers
  - (ii) Deputy Speaker
  - (iii) Leader of Opposition.
  - (IV) Chief Secretary
  - (v) State Election Commissioner
- 3. The men in uniform and operational agencies requiring unhindered access to the roads to perform their duties shall not be entitled to have red light but can use Blue, white, multicolour etc. as specified hereunder:
  - a) Multi-Coloured Lights (Blue, Red and White):
    - (i) Ambulance Services
    - (ii) Fire service vehicles
    - (iii) Police Vehicles used as escorts or pilots to high dignitaries.
  - b) Blue Light with Flasher:
    - Police Vehicles used for law and order duties.
    - (ii) State Excise Department Vehicles
    - (iii) Revenue and Disaster Management Department vehicles.
    - (IV) Transport Department Vehicles.



- The following category of vehicles may be fitted with multi-tone norns under rule 119(3) of the Central Motor Vehicle Rules, 1989.
  - Ambulance vehicles
  - Fire service vehicles ii)
  - Police vehicles including Pilot, Escorts or on Law & Order (iii)

Construction equipment vehicles. iv)

- Motor Vehicles Department vehicles (Transport Department). **V**}
- When the dignitaries are not travelling in the vehicles fitted with red lights, it should be ensured that the same are covered by black cover.
- The Police Officers and other authorities entrusted with the task enforcing the provisions of the Motor Vehicles Act 1986 and the rules framed hereunder shall ensure i... imposition of appropriate penalty on the defaulting vehicles except those specified assigned under rule 108, and rule 119(3) of Central Motor Vehicle Rules, 1989 as amended from time io lime

Attention of the Heads of Departments/Offices and Chief Executive Officers of Corporations/Boards etc is invited to the G.O. first cited on the subject mentioned above, wherein it has been notified that only the vehicle carrying the following high dignitaries are permitted to use red lights on their top front of the vehicle:

# Red light with flasher

- 1. Lieutenant Governor
- 2. Chief Minister
- 3. Speaker
- 4. All Ministers
- 5. Deputy Speaker
- 6. Government Whip
- 7. Parliamentary Secretary to Chief Minister
- 8. Leader of Opposition

# Red light without flasher

- 1. Chief Secretary
- 2. Collector
- 3. Chief Judge
- 4. Inspector General of Police
- 5. Regional Administrator
- 2. Despite the Orders first cited, red lights are found to be used by vehicles carrying persons other than the high dignitaries notified above. Usage of Red lights of any kind contrary to the extant orders, is against the Motor Vehicles Act and Rules. The Hon'ble High Court is now seized of the matter vide reference 3<sup>rd</sup> cited above.

3. The Heads of Departments/Offices and Chief Executive Officers of Corporations/Boards etc are hereby instructed to arrange to remove the red lights fitted in the vehicles not covered in the above said categories on or before 14.11.2012 without fail. A Compliance report thereon shall be sent to the Transport Commissioner, Puducherry, before 10.00 A.M. on 15.11.2012 so as to submit a report to the Hon'ble High Court, Chennai by the Chief Secretary to Government, Puducherry.

- (c) In case the vehicle fitted with red light on top front is not carrying the dignitaries, then such red light shall not be used and be covered by a black cover.

#### NOTIFICATION

In exercise of the powers conferred under clause (iii) of rule 108 of the Central Motor Vehicles Rules, 1989, the Lieutenant-Governor, Pondicherry is pleased to specify the following dignitaries for whom the restriction of "showing red light to the front or light other than red to the rear" as provided in rule 108 shall not apply, and the display of such lights by the vehicles used by such dignitaries shall be regulated in the following manner, namely:-

(1) Revolving-cum-red light ... Vehicles on emergency duty such as pilot vehicles, fire brigades, vehicles of Pondicherry Police Control Room only. The light shall be fixed on the top at the middle of the roof.

(2) Red light without flasher ...

Lieutenant-Governor, Pondicherry, Chief Minister, Ministers, Speaker and Deputy Speaker. The light shall be fixed in front and at the top of the windscreen position of a saloon vehicle.

(3) Blue fixed flasher light

Official vehicles in attendance with the above dignitaries. The light shall be in front and middle of the roof while plying on official duty only.

(4) Blue revolving light

Police patrol vehicles, ambulances and vehicles on checking/enforcement duty only of Transport Department. The light shall be fixed in front of the vehicle at the top of the windscreen position.

(5) Red light without flasher ... on bonnet.

In case the Chief Minister, Ministers, Speaker and Deputy Speaker desire, they can have this light on the front of the bonnet of motor vehicles in place of red light without flasher. The Collector, Pondicherry and the Administrators, Karaikal, Mahe and Yanam can also use this light on the bonnet. This light shall be allowed to be used on other vehicles of senior officials, only after getting the approval of the Chief Secretary.

2. When the dignitaries are not travelling in the vehicles fitted with red lights, it should be ensured that the same are properly covered.
